Below you will find key highlights and important information on how to register for the event.

- All licensees attending the Industry User Group must first register for Metrc Learn, the recently redesigned learning management system.
 - Once registered for Metrc Learn, licensees must complete the New Business Training.
 - Upon completing New Business Training, the course titled WV Metrc Industry User Group 8/8/24 will be available.

Register for Metrc Learn

Metrc Learn was recently redesigned to provide users with interactive, educational information on system functionality to expand skillsets and drive workflow efficiencies. To register for a Metrc Learn account, take the following steps:

- 1. Navigate to the Metrc Learn login page by:
 - Using the new link: <u>learn.metrc.com</u>; or
 - From within the Metrc system Navigate to the Support area dropdown on the navigational toolbar "Sign up for Training".
- 2. Click the 'Register' link next to 'New user?' see Figure 1.

Once the 'Register' link is clicked, the registration page will appear.




Figure 2: Registration - User profile

3. From the registration page, complete all required information on the form. The password must include at least 9 characters. When complete, click 'Next' – see Figure 2.




Figure 3: Registration - Additional fields

4. On the next page, fill in all additional fields and click 'Register' – see Figure 3.

Upon approval of active Metrc Learn status, which can take up to 48 hours, or 2 business days, an email invitation will be sent to the email provided to set a password.

Note: If working in multiple licenses, enter all licenses on the lines provided, and then select the license type that reflects the area of the role requesting access to Metrc training.

Once the email invitation is received, navigate to the <u>Metrc Learn login page</u> to sign in and access training.

How to register for the August Industry User Group session

Registration for the upcoming August 8th, 2024, Industry User Group session will be facilitated through Metrc Learn.




Figure 4: Metrc Learn Course Catalog

Upon login, the Dashboard will show the "WV Metrc Industry User Group 8/8/24" module or, alternatively, registration is available in the "Course Catalog" – see Figure 4.




Figure 5: Register and enroll for "WV Metrc Industry User Group 8/8/24"

After selecting the "WV Metrc Industry User Group 8/8/24" module, registration confirmation will be required. To complete registration, click on the "WV Metrc Industry User Group 8/8/24" event, then click on the "Enroll" button – see Figure 5 below.




Figure 6: Registration confirmation email

Once registered, a confirmation e-mail will be sent from learn@metrc.com with a link to join the virtual event at the designated time – see Figure 6.
