Register for Metrc Learn

Metrc Learn was recently redesigned to provide users with interactive, educational information on system functionality to expand skillsets and drive workflow efficiencies. To register for a Metrc Learn account, take the following steps:

1. Navigate to the Metrc Learn login page by:
 - o Using the new link: learn.metrc.com; or
 - o From within the Metrc system – Navigate to the Support area dropdown on the navigational toolbar “Sign up for Training”.

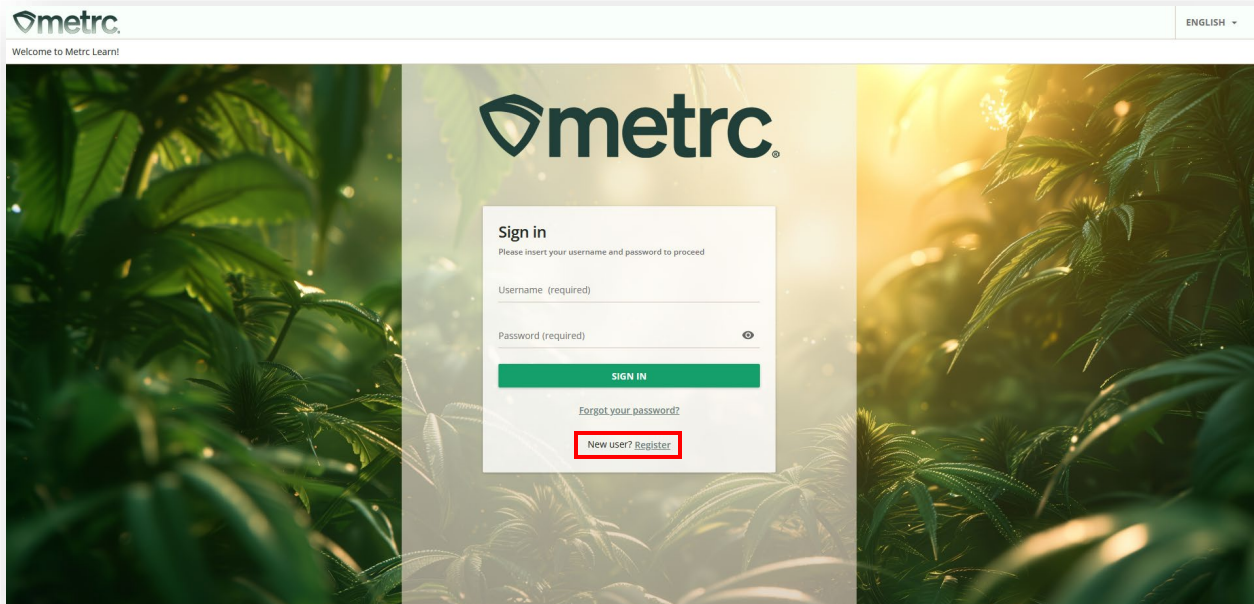
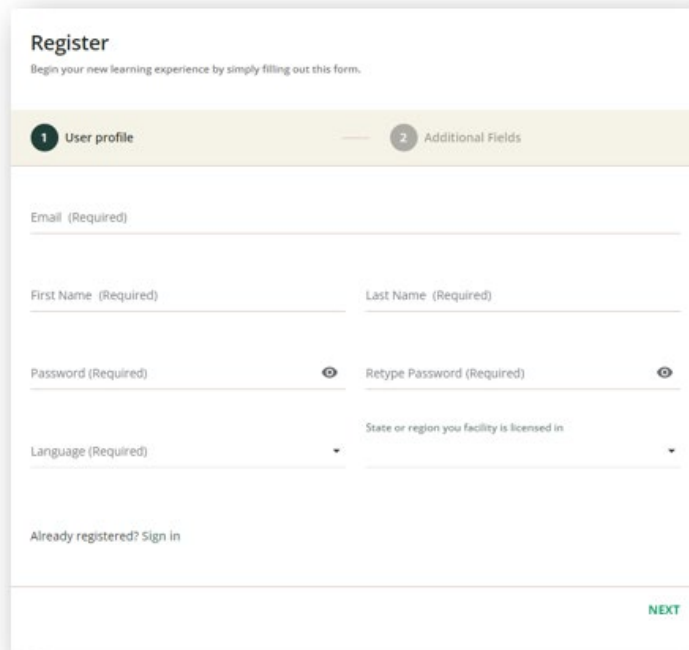


Figure 1: Metrc Learn login page

2. Click the ‘Register’ link next to ‘New user?’ – **see Figure 1.**


