Reason: To introduce a new feature that allows licensees to optionally include an Invoice Number on transfer manifests.		

Greetings,

On 10/22/2024 Metrc was updated to allow licensees to optionally include an *Invoice Number* on transfer manifests.

This enhancement is described in detail on the following pages.

Optional Invoice Number on Transfer

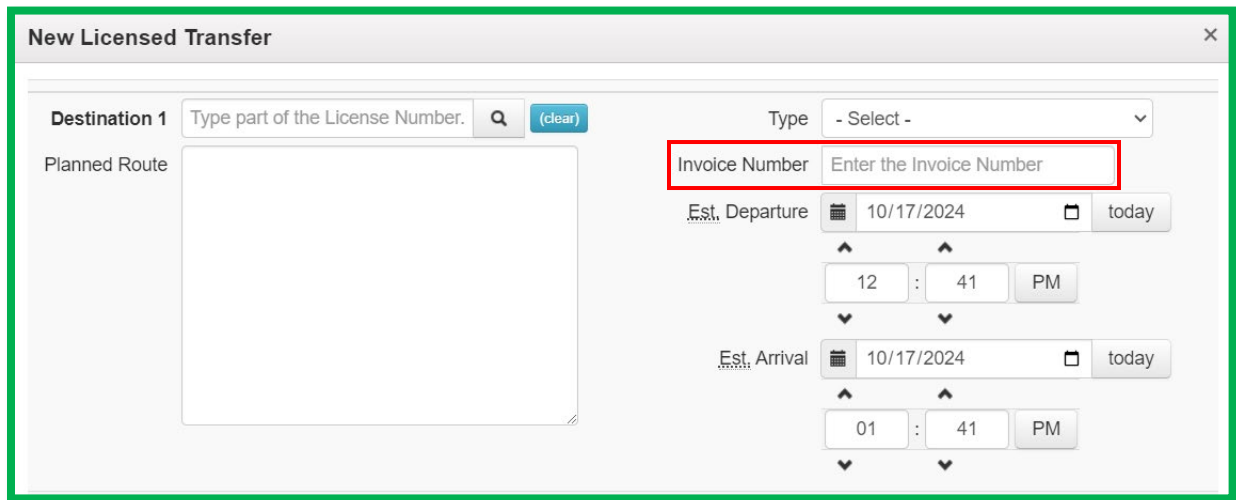


Figure 1: Invoice Number Field in New Licensed Transfer Action Window

When creating or editing a transfer, a new optional *Invoice Number* field displays on the action window - see **Figure 1**.

An entry in the *Invoice Number* field is **NOT** required, but it can optionally be used by origin licensees who find it helpful to include this information on the transfer/transfer manifest.

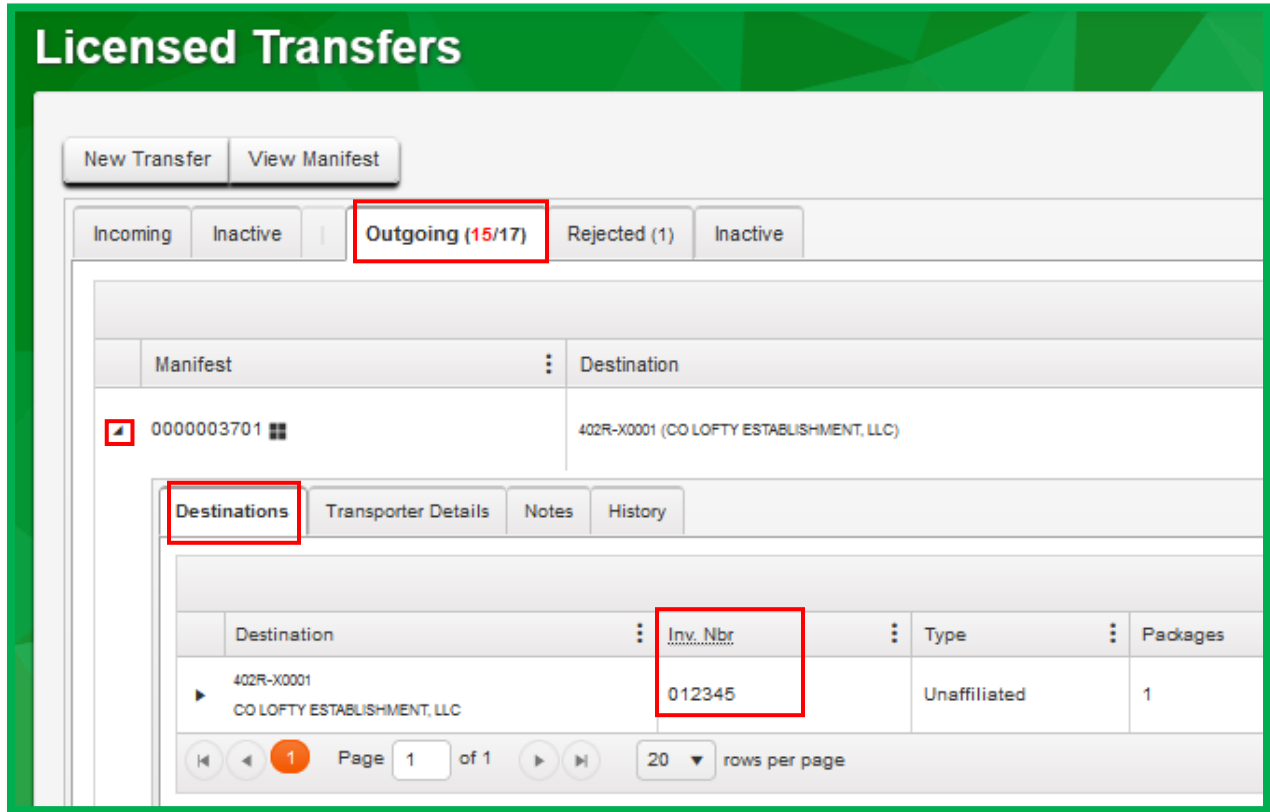


Figure 2: Invoice Number Field on Outgoing Tab Drilldown

The *Invoice Number* field can be viewed by the origin licensee in the manifest drill-down on the *Outgoing* tab on the *Licensed Transfers* grid - see **Figure 2**.

The *Invoice Number* field can be viewed by the destination licensee on the *Incoming* tab of the *Licensed Transfers* grid - see **Figure 3**.

Invoice Number on Transfer Manifest

The new *Invoice Number* field also displays when viewing or printing a manifest. It will be populated with a value only if the origin licensee opted to include this information when creating or editing the transfer.

An example of the new *Invoice Number* field on the transfer manifest is shown below - see **Figure 4**.
